## SUMMARY ORDER TO DENY UPHELD

ON THE 26th day of October, 2005 the above-captioned matters came on for a pre-hearing before Sandra Sharon, the Board's designated Hearing Officer. The Petitioner appeared by and through Assistant Attorney General Betty Wright, Disciplinary Counsel for the Board. The respondent appeared on her own behalf by telephone conference.

Wherefore, the hearing officer finds as follows:

- 1. Respondent applied for licensure as a registered nurse on 10/04/2004.
- 2. A Summary Order denying licensure was issued on 5/24/2005.
- 3. Respondent filed a timely appeal ON 6/01/2005.
- 4. Respondent's address of record is 21715 w. 29<sup>TH</sup> St. N, Andale, KS 67001.
- 5. Petitioner sent a copy of the petition and notice of this hearing to respondent's last known address and service is proper.
- 6. The respondent moved to withdraw her request for a hearing. The respondent states that she is not planning to go back in to the work force as a nurse for a few years, and the KNAP program is not designed to be completed until the nurse has worked in the field. The respondent is not in a financial position to afford KNAP unless she is working, and she can not work currently due to needing to care for her children.
- 7. The respondent's request to withdraw her request for a hearing is granted.
- 8. The respondent may reapply for a license.
- 9. The Summary Order to Deny reinstatement issued May, 24, 2005 is upheld.
