REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Nancy K. Durrett, R.N., M.S.,

serving as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal

conference on January 10, 2017, in Henrico County, Virginia, to inquire into evidence that Ashly

Nicole Sherman, R.M.A., may have violated certain laws and regulations governing the practice of

medication aides in the Commonwealth of Virginia.

Ms. Sherman did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated September 13, 2016, the Board sent a Notice of Informal Conference ("Notice")

to Ms. Sherman notifying her that an informal conference would be held on November 9, 2016. The

Notice was sent by certified and first class mail to the legal address of record on file with the Board.

Ms. Sherman requested and received a continuance. By letter dated December 8, 2016, the Board sent

an Amended Notice of Informal Conference to Ms. Sherman notifying her that an informal conference

would be held on January 10, 2017. The Amended Notice was sent by certified and first class mail to

the legal address of record on file with the Board. Neither the certified mail nor the certified mail

receipt were returned to the Board office. The Amended Notice sent by first class mail was not

returned to the Board office. Accordingly, the Agency Subordinate concluded that adequate notice was provided to Ms. Sherman and the informal conference proceeded in her absence.

Recommended Findings of Fact and Conclusions of Law

- 1. Ashly Nicole Sherman, R.M.A., was issued Registration Number 0031-009264 to practice as a medication aide on March 14, 2016, which is scheduled to expire on December 31, 2017. At all times relevant to the findings herein, said registration was in full force and effect.
- 2. Ms. Sherman violated Virginia Code § 54.1-3007(6) in that she is unsafe to practice as a medication aide due to her admitted addiction to opiates. Further, on June 5, 2016, during the course of her employment with Timberview Crossing Assisted Living, Timberville, Virginia, Ms. Sherman tested positive for opiates during a facility-wide drug screen.
- 3. Ms. Sherman violated Virginia Code § 54.1-3007(2), (5) and (6) and 18 VAC 90-60-120(2)(c) of the Regulations Governing the Registration of Medication Aides in that on July 21, 2016, during an interview with the Timberville Police Department, Ms. Sherman admitted that during the course of her employment at Timberview Crossing Assisted Living, in September 2015, she diverted 30 hydrocodone (C-II) tablets for her personal and unauthorized use.
- 4. On July 19, 2016, during an interview with a Department of Health Professions investigator, Ms. Sherman admitted that she had been addicted to opiates for four years. She reported entering substance abuse treatment at Harrisonburg Treatment Center and being on methadone. Ms. Sherman's counselor reported that as of July 28, 2016, all drug screens were negative.
- 5. As of July 19, 2016, Ms. Sherman remained employed at Timberview Crossing Assisted Living.
- 6. On November 21, 2016, in the Rockingham County, Virginia, Circuit Court, Ms. Sherman was indicted for possession of a controlled substance, a felony, based on her diversion from

Timberview Crossing Assisted Living. Ms. Sherman pled guilty and was placed on deferred

disposition for two years.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate

recommends that the Board issue an Order as follows:

1. The registration issued to Ashly Nicole Sherman, R.M.A., to practice as a medication aide

in the Commonwealth of Virginia is INDEFINITELY SUSPENDED.

2. The registration of Ashly Nicole Sherman, R.M.A., will be recorded as SUSPENDED.

3. Should Ashly Nicole Sherman, R.M.A., seek reinstatement of her registration, an

administrative proceeding shall be convened to consider such application. At such time, the burden

shall be on Ms. Sherman to demonstrate that she is safe and competent to return to practice as a

medication aide. Ms. Sherman shall be responsible for any fees that may be required for the

reinstatement and/or renewal of the registration prior to issuance of the registration to resume practice.
