AMENDED REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Nancy Durrett, R.N., M.S., serving

as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on

November 9, 2016 in Henrico County, Virginia, to inquire into evidence that Delsa Michelle Sally,

C.N.A., may have violated certain terms and conditions imposed on her by an Order of the Board

entered February 1, 2012 ("Board's Order"), and certain laws governing the practice of certified nurse

aides in the Commonwealth of Virginia.

Ms. Sally did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated September 26, 2016, the Board sent a Notice of Informal Conference ("Notice")

to Ms. Sally notifying her that an informal conference would be held on November 9, 2016. The

Notice was sent by certified and first class mail to the legal address of record on file with the Board.

On September 29, 2016, Ms. Sally requested that the Postal Service redeliver the Notice sent by

certified mail on September 30, 2016. The Notice sent by first class mail was not returned to the

Board office. Accordingly, the Agency Subordinate concluded that adequate notice was provided to

Ms. Sally and the informal conference proceeded in her absence.

Recommended Findings of Fact and Conclusions of Law

- 1. Delsa Michelle Sally, C.N.A., was issued Certificate Number 1401-155396 to practice as a nurse aide on August 30, 2012, which expired on August 31, 2015.
- 2. By Board's Order entered February 1, 2012, the application of Ms. Sally to practice as a certified nurse aide was approved, and she was placed on indefinite probation for a period of not less than two years of active nurse aide employment. The action was the result of Ms. Sally's substance abuse and extensive criminal history.
- 3. Delsa Michelle Sally, C.N.A., violated Term Number 2(b) of the Board's Order, which required her to notify the Board within ten days of the date she began nurse aide practice, in that she failed to notify the Board of her employment with All Nurses Care, Richmond, Virginia, until April 14, 2014, when, in fact, her employment began on February 14, 2014.
- 4. Ms. Sally violated Term Number 2(c) of the Board's Order, which required her to inform each employer that she was on probation and provide them with a copy of the Order, in that Ms. Sally failed provide her employer, All Nurses Care, with a copy of the Order.
- 5. Ms. Sally violated Term Number 2(d) of the Board's Order, which required her to direct her employer to submit performance evaluations quarterly, in that performance evaluations were not received for the periods ending March 31, 2014, June 30, 2014, September 30, 2014, December 31, 2014, and March 31, 2015.
- 6. Ms. Sally violated Virginia Code § 54.1-3007(6) and Term Number 2(f) of the Board's Order, which required her to attend one of the following recovery organizations two times per week: Alcoholics Anonymous, Narcotics Anonymous, Cocaine Anonymous, Caduceus recovery support groups or other groups acceptable to the Board, in that Ms. Sally did not submit attendance logs for

October 2014, November 2014, or any month after April 2015. In the log for December 2014, she documented that she attended seven meetings. In the log for April 2015, she documented that she attended one meeting.

7. Ms. Sally violated Term 2(i) of the Board's Order, which required her to submit self-reports quarterly, in that many of the self-reports were received late and the reports due June 30, 2015, September 30, 2015, December 31, 2015, and March 31, 2016, were not submitted to the Board.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

- 1. Delsa Michelle Sally, C.N.A., is REPRIMANDED.
- 2. The right of Ms. Sally to renew her certificate to practice as a nurse aide in the Commonwealth of Virginia is INDEFINITELY SUSPENDED.
 - 3. The certificate of Ms. Sally will be recorded as SUSPENDED.
- 4. Should Ms. Sally, seek reinstatement of her certificate, an administrative proceeding shall be convened to consider such application. At such time, the burden shall be on Ms. Sally to demonstrate that she is safe and competent to return to the practice as a nurse aide. Ms. Sally shall be responsible for any fees that may be required for the reinstatement and/or renewal of the certificate prior to issuance of the certificate to resume practice.
