 - Approve your application and issue a restricted license subject to terms and conditions.

STATEMENT OF ALLEGATIONS

The Board of Nursing alleges that grounds exist to refuse to reinstate the license of William Holt Vest to practice professional nursing in that:

- 1. Mr. Vest violated Virginia Code § 54.1-3007(6) in that he is unsafe to practice professional nursing due to mental illness, as evidenced by the following:
- a. Between January and March 2016, Mr. Vest received inpatient psychiatric treatment on five occasions for depression, anxiety, and suicidal ideations. His discharge diagnoses included adjustment disorder with depression and anxiety; rule out malingering; and major depressive disorder, severe, recurrent.
- b. Mr. Vest received outpatient treatment at Blue Ridge Behavioral Services, Roanoke, Virginia beginning in November 2015 until he was discharged from the practice on or about March 31, 2016 for missing three appointments. Mr. Vest's diagnoses included major depressive disorder, recurrent; generalized anxiety disorder; and dependent personality disorder.
- c. On or about May 19, 2016, Mr. Vest's previous primary care physician told an investigator for the Department of Health Professions that Mr. Vest was a danger to himself and others, and that in her opinion, he was not safe to practice nursing due to psychiatric concerns.
- 2. Mr. Vest violated Virginia Code § 54.1-3007(1) and 18 VAC 90-20-300(A)(1)(b) of the Regulations Governing the Practice of Nursing in that on his application for reinstatement of his nursing license submitted to the Board on or about April 5, 2016, Mr. Vest falsely answered "no" to the question "do you have a mental, physical, or chemical dependency condition which could interfere with your current ability to practice nursing." In fact, Mr. Vest has a long history of mental illness, as set forth in Allegation No. 1.
