CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Diondra Ardelia Ward, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Ward's application for registration by examination to practice as a medication aide in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Diondra Ardelia Ward, submitted an application for registration by examination to practice as a medication aide in the Commonwealth of Virginia on June 9, 2016.
- 2. Ms. Ward violated Virginia Code § 54.1-3007(4) in that she was convicted of the following misdemeanor crimes of moral turpitude in the general District Court of Gloucester County, Virginia:
 - a. On November 1, 2007, she was convicted of petit larceny.
 - b. On February 28, 2008, she was convicted of check fraud.
 - 4. Ms. Ward otherwise meets the requirements of Virginia Code § 54.1-3042.

CONSENT

Diondra Ardelia Ward, by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;

- 2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; the right to representation by counsel; and the right to cross-examine witnesses against me;
 - I waive all right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusion of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for registration by examination to practice as a medication aide in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- Diondra Ardelia Ward is REPRIMANDED.
- 2. The application of Diondra Ardelia Ward, for registration to practice as a medication aide in the Commonwealth of Virginia is APPROVED. Upon successful completion of the medication aide examination, Diondra Ardelia Ward shall be issued an unrestricted registration.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
