NOTICE OF HEARING

Pursuant to § 2.2-4020, 2.2-4021, § 54.1-110, and § 54.1-2400(11) of the Code of Virginia (1950), as amended, Crystal J. Breeden, L.P.N., is hereby given notice that, pursuant to § 2.2-4024(F), a formal administrative hearing will be held in the presence of a panel of the Board of Nursing ("the Board"). The hearing will be held on January 16, 2002, at 9:30 a.m., at the offices of the Department of Health Professions, (Southern States Building), 6606 West Broad Street, Fourth Floor, Richmond, Virginia, at which time Ms. Breeden will be afforded the opportunity to be heard in person or by counsel.

At the hearing Ms. Breeden has the following rights, among others: the right to representation by counsel, the right to have witnesses subpoenaed and to present witnesses on her behalf, the right to present documentary evidence and the right to cross-examine adverse witnesses. If Ms. Breeden desires any witnesses to appear on her behalf, she must notify the Director of the Administrative Proceedings Division, 6606 West Broad Street, Richmond, Virginia 23230-1717, giving the names and address of the witnesses, at least fifteen (15) days prior to the date of the hearing in order that subpoenas may be issued.

The purpose of the hearing is to receive and act upon evidence that Ms. Breeden may have violated certain laws and regulations governing the practice of nursing in Virginia, as more fully set forth in the Statement of Particulars below.

STATEMENT OF PARTICULARS

The Board alleges that Crystal J. Breeden, L.P.N., may have violated § 54.1-3007(2), (5), (6) and (8) of the Code of Virginia (1950), as amended, and 18 VAC 90-20-300(A)(2)(c), (e) and (f) of

the Board of Nursing Regulations, in that:

- 1. During the course of her employment with Eldercare Gardens, Charlottesville, Virginia:
 - a) By her own admission, from approximately August 1999 until May 2000, Ms. Breeden diverted oxycodone and hydrocodone medications (Schedule II controlled substances) for her personal and unauthorized use, and self-administered these medications. Ms. Breeden accomplished the diversion by signing out medications and documenting them as being administered and keeping the medication for herself.
 - On or about April 24, 2000, Resident A was ordered a 25mcg Duragesic patch (fentanyl, Schedule II). The instructions were to apply "one patch topically, change every three days, remove old patch first." During the month of May 2000, Ms. Breeden failed to change the patch as ordered. On several dates, Ms. Breeden documented the withdrawal and administration of a patch; however, the patch could not be located on the resident. Further, on several occasions Resident A was observed without a patch, and a day or two later, she was observed wearing a post-dated patch administered by Ms. Breeden.
 - c) On or about May 10, 2000, Ms. Breeden submitted a fraudulent order to the pharmacy to increase Resident A's Duragesic patch from 25mcg to 50mcg per Dr. Dandridge; however, Dr. Dandridge did not authorize the increase and was considering discontinuing the medication due to side effects the resident was experiencing.
 - d) On or about March 29, 2000, Resident B was ordered a 50mcg Duragesic patch. The instructions were to apply "one patch topically, change every three days, remove old patch first." During the month of May 2000, Ms. Breeden failed to change the patch as ordered, resulting in the resident experiencing severe back pain.

2. On or about June 1, 2000, Ms. Breeden entered a Participation Contract with the Health Practitioners' Intervention Program ("HPIP"). On or about December 8, 2000, the HPIP Committee granted her a stay of disciplinary action regarding the diversion from Eldercare Gardens. On or about April 20, 2001, the stay was vacated and Ms. Breeden was dismissed from the program, for failing to:

- a) return a signed Recovery Monitoring Contract;
- b) attend 12-step meetings and/or Caduceus;
- c) call for or submit to urine drug screens;
- d) respond to telephone messages and written correspondence regarding her noncompliance; and
- e) submit monthly self-reports.
