CONSENT ORDER

The Virginia Board of Nursing, and Marcia L. Rollins, L.P.N., with her consent as evidenced by her signature below, enter into the following Consent Order affecting Ms. Rollins' license to practice practical nursing in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Marcia L. Rollins holds License No. 0002-063897 issued by the Virginia Board of Nursing.
2. Ms. Rollins violated § 54.1-3007(2) and (5) of the Code of Virginia, 1950, as amended ("Code") and 18 VAC 90-20-300(A)(2)(f) of the Board of Nursing Regulations, in that, on or about June 24, 2005, while working on the Alzheimer's unit of King's Daughters Community Health and Rehabilitation Center, Staunton, Virginia, she failed to conduct a search for a missing resident, an elderly woman with Alzheimer's disease, who was found several hours later face down and unresponsive on the facility's patio. The resident was rushed to the hospital and treated for bruises, dehydration, and heat exhaustion. Ms. Rollins had been trained regarding the facility's protocol for locating missing residents and violated said protocol when she did not report the missing resident to her charge nurse or organize a search for the resident.

CONSENT

Marcia L. Rollins, L.P.N., by affixing her signature hereon, agrees to the following:

1. Ms. Rollins acknowledges that she has been specifically advised to seek advice of counsel prior to signing this document;

2. Ms. Rollins acknowledges that she is fully aware that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A), et seq., of the Code;
3. Ms. Rollins acknowledges that she has the following rights among others: the right to an informal fact finding conference before the Board, to reasonable notice of said administrative proceeding, to representation by counsel, and the right to present witnesses and evidence on her behalf;
4. Ms. Rollins waives all such right to an informal conference;
5. Ms. Rollins admits to the above Findings of Fact;
6. Ms. Rollins consents to the entry of the following Order affecting her practice of practical nursing in the Commonwealth of Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Consent Order, and in lieu of further proceedings, hereby Orders that Marcia L. Rollins, L.P.N., who holds License No. 0002-063897, be and hereby is REPRIMANDED. The Board expects Ms. Rollins to maintain a course of conduct in her capacity as a licensed practical nurse commensurate with the requirements of Title 54.1, Chapter 30, of the Code of Virginia (1950), as amended, and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Consent Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.
