ORDER

In accordance with §§ 2.2-4019, 2.2-4021 and 54.1-2400 (10) of the Code of Virginia (1950), as amended ("Code"), an informal conference was conducted on behalf of the Virginia Board of Nursing ("Board") on October 29, 2013, in Henrico County, Virginia. Ms. Jordan was present and was not represented by legal counsel. Judith Piersall, R.N., B.S.N., serving as Agency Subordinate for the Board, submitted a Recommended Decision for consideration.

On January 29, 2014, a quorum of the Board met to receive and act upon the Recommended Decision of the Agency Subordinate. Ms. Jordan was not present nor was she represented by legal counsel.

Based upon its review of the Recommended Decision of the Agency Subordinate, the Board makes the following Findings of Fact and Conclusions of Law and issues the following Order.

FINDINGS OF FACT

 Shenecole Jordan was issued Certificate No. 1401-146638 to practice as a nurse aide in Virginia on July 21, 2011. The certificate expired on July 31, 2013.

2. By letter dated October 2, 2013, the Virginia Board of Nursing sent a Notice of Informal Conference ("Notice") to Ms. Jordan notifying her that an informal conference would be held on October 29, 2013. The Notice was sent by certified and first class mail to 1142 Jebs Place, Newport News, Virginia 23607, the address of record on file with the Board of Nursing.

During her employment with Newport News Nursing & Rehabilitation, Newport News,
Virginia, on May 21, 2013:

- a. Ms. Jordan only provided care for Resident A once in the morning during her 7:00 a.m. to 3:00 p.m. shift.
- b. When Resident A asked Ms. Jordan for assistance with using the bedpan, Ms. Jordan rudely said, "now she wants to use the bedpan."
- c. After Ms. Jordan assisted Resident A onto the bedpan at the end of her shift, Ms. Jordan left Resident A on the bedpan, and she failed to return to provide care to Resident A. Resident A was found on the bedpan by the oncoming shift approximately 30 minutes later.
- 4. At the informal conference, Ms. Jordan stated that she checked on Resident A on three occasions during her shift. She further stated that at the end of her shift and at the time Resident A was on the bedpan, a nurse aide with the oncoming shift told her that she would take care of Resident A. Resident A, who is alert and orientated, stated to a Department of Health Professions investigator that Ms. Jordan never provided good care, and had an attitude. Seven members of the residents' council at Newport News Nursing & Rehabilitation reported that Ms. Jordan provided poor care. Newport News Nursing & Rehabilitation hired Ms. Jordan on August 29, 2012, and terminated her employment on June 20, 2013, at a result of the above incident. During her employment at Newport News Nursing & Rehabilitation, Ms. Jordan received six written employee corrective action reports.

CONCLUSIONS OF LAW

Finding of Fact #3 constitutes a violation of § 54.1-3007 (5) of the Code.

ORDER

WHEREFORE, it is hereby ORDERED as follows:

- 1. Shenecole Jordan, C.N.A., is hereby REPRIMANDED.
- 2. Ms. Jordan shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing

Regulations.

Pursuant to § 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

Pursuant to Section 54.1-2400(10) of the Code, Ms. Jordan may, not later than 5:00 p.m., on March 11, 2014, notify Jay P. Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
