### **ORDER**

Pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), a Special Conference Committee ("Committee") of the Virginia Board of Nursing ("Board") met on August 19, 2013, in Henrico County, Virginia, to receive and act upon Kenyatta Y. Manzie's application for reinstatement of her certificate to practice as a nurse aide in Virginia and inquire into evidence that Ms. Manzie may have violated certain laws and regulations governing nurse aide practice. Ms. Manzie was present and was not represented by counsel. Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law.

## FINDINGS OF FACT

- 1. Kenyatta Y. Manzie was issued Certificate No. 1401-108708 to practice as a nurse aide in the Commonwealth of Virginia on May 17, 2005. Said certificate expired on May 31, 2009. Ms. Manzie was issued License No. 0002-079574 to practice as a practical nurse in the Commonwealth on November 13, 2008. Said license was suspended by Order of the Board dated March 28, 2013. Ms. Manzie's primary state of residence is Virginia.
- 2. By letter dated July 24, 2013, the Board of Nursing sent a Notice of Informal Conference ("Notice") to Ms. Manzie notifying her that an informal conference would be held on August 19, 2013. The Notice was sent by certified and first class mail to 118 Bayhaven Drive, Hampton, Virginia, 23666, the address of record on file with the Board of Nursing.
- 3. Ms. Manzie submitted an application for reinstatement of her certificate to practice as a nurse aide, which was received by the Board on May 24, 2013.

- 4. By Order of the Board dated November 10, 2011, while she was licensed as a practical nurse, Ms. Manzie was placed on probation for inadequate care in her nursing practice.
- 5. By Order dated March 28, 2013, the Board reprimanded Ms. Manzie and indefinitely suspended her license to practice practical nursing after making findings that she had violated multiple terms of her probation and that she had additional standard of care issues in her practice while on probation.
- 6. Ms. Manzie did not present any evidence at the informal conference that she had taken any C.N.A. refresher courses even though she has not practiced as a C.N.A. since 2009.

### CONCLUSIONS OF LAW

- 1. Finding of Fact No. 5 constitutes a violation of § 54.1-3007(2) of the Code and 18 VAC 90-25-100(2)(f) of the Regulations Governing Certified Nurse Aides.
- 2. The Board concludes that Ms. Manzie has not demonstrated satisfactory evidence that she is prepared to resume practice in a safe and competent manner.

#### **ORDER**

On the basis of the foregoing, the Committee hereby ORDERS that Kenyatta Y. Manzie's application for reinstatement of her certificate to practice a nurse aide is hereby DENIED.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.

Pursuant to Section 54.1-2400(10) of the Codé, Ms. Manzie may, not later than 5:00 p.m., on October 15, 2013, notify Jay P. Douglas, Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
